Qin's Representative Cases: a gang-involved case in Wuhan (charges of extortion, affray and intentional destruction of property) resulting in an acquittal; the case of taking-bribes by leveraging influence committed by a person with a special relationship to the president of a Wuhan commercial bank headquarters (amount involved: approximately RMB 5 million, sentence: 3 years and 3 months' imprisonment); the bribery case of a person with a special relationship to the president of a nationally well-known hospital (amount involved: approximately RMB 6.5 million, sentence: 3 years and 6 months' imprisonment); representing an enterprise in filing a criminal accusation against a project manager for occupational embezzlement (Wuhan Yangtze Memory-National Memory Base Project); the organised examination-cheating case under the jurisdiction of Huanggang City designated by the Higher People's Court of Hubei Province (supervised by the Ministry of Public Security, the most influential and highest-value case of its kind nationwide, probation granted); the case of production and sale of counterfeit-quality products of a Wuhan-based company (a case affiliated with

Hefei Three Sheep, amount involved: tens of millions RMB, conviction amended to the crime of false advertising, probation granted); the case of major-accident-liability offence against a Wuhan renewable-resource company arising from the “November 8 , 2020” catastrophic fire incident in Jiangxia District, Wuhan (case dismissed).
